Introduction





Digital Credentials for Europe (DC4EU) is a multinational **consortium**, lead by the Spanish Ministry of Economic Affairs and Digital Transformation and conformed by **80 organizations** from **22 countries** (20 EU Member States + Norway and Ukraine).



The **aim** of the proposal is to develop **large-scale piloting projects** of the **EUDI reference wallet** addressing two use cases in compliance with the EU toolbox process.



The work of the consortium will be carried out during a **two-year period** and will be guided by the **iterative releases** of the EUDI reference wallet.



Objetives





Interoperability and scalability will be tested in the **national domain and in multiple cross-border contexts**, with the purpose of **providing feedback** to the EC and MS **for iterative updates** through specific coordination work packages, project management processes and tasks.



To show how a decentralized approach, supported by the Verifiable Credentials model and the power of electronic ledgers (EBSI), is an actionable solution that fits the EIDAS2 requirements.



Also to enhance the privacy of citizens and interoperability of data in the exchange of personal information in the fields of education and social security in a cross-border context.












EUIDW: eIDAS toolbox mapped into SSI architecture










Social Security Use Case
